Common Terms of Reference

• Regular Time or Full Time

Unless listed either in conjunction with the bet offer, or else in the Sport Specific rules, all bets should be considered valid for the result at the end of the 'Regular Time' or 'Full Time' only. 'Regular Time' or 'Full time' is defined as interpreted by the official rules published by the respective governing association. For example, for Soccer regular or full time is stipulated to be 90 minutes including injury time but excluding extra time or penalties.

Live or In-Game Betting

'Live' or 'In-Game' betting is where it is possible to bet during an ongoing game or event. Mount Airy Sportsbook does not acknowledge or accept any liability whatsoever if it is not possible to place a bet, or if the live score update is not correct. At all times it is the player's responsibility to be aware of the game/events and situations surrounding it such as the current score, its progression and how much time remains before the game/event is completed. Mount Airy Sportsbook does not accept any liability for changes to the live betting schedule or interruption of the live betting service.

General

- Management reserves the right to modify the House Rules, subject to regulatory approval.
- Management reserves the right to refuse the whole or any part of any bet request for any reason and at our sole discretion. Individual bet requests may be reviewed, and an alternative price/line or maximum stake offered at our sole discretion.
- Management reserves the right to determine minimum and maximum wager limits on all events, including on a wager by wager basis.
- Pennsylvania Law prohibits persons under the age of 21 from wagering, collecting winning wagers, or loitering in and/or about the Sports Book area.
- Management is not responsible for lost, stolen or misplaced, altered or unreadable wagering tickets
- The maximum total winnings to any customer on any calendar day for bet placed with Mount Airy Sportsbook is \$100,000 (hereafter the "Maximum Daily Payout").
- The maximum payout for any single wager or parlay is the lower of \$50,000 or the Sport's Specific maximum payout (hereafter the "Maximum Ticket Payout")
- Management reserves the right to refuse/cancel any bet or part of a bet before the game starts
 and to make ambiguous bets void. We reserve the right to correct obvious errors (palpable)
 and apply revised odds/lines for final settlement across pre-game and in-play wagering.
- Management does not accept any responsibility for typing, human or palpable errors, which lead
 to obvious price errors. In such cases all bets will be adjusted to the best available market price
 for the customer at the time of the wager being placed.

Dates & Times

The deadline (cut-off time) shown on the Betting Kiosks or television displays within the casino is to be treated for information purposes only. Mount Airy Sportsbook reserves the right, at its own discretion, to suspend, partially or completely, the wagering activity at any time where it deems necessary. Time shown on printed tickets is Eastern Time.

Stats & Form

Statistics or editorial text published on Betting Kiosks or shown on television displays within the casino is to be considered as added information. Mount Airy Sportsbook does not acknowledge or accept any liability whatsoever if the information is not correct. At all times it is the player's responsibility to be aware about circumstances relating to an event.

Displayed Information

On some events we may display a score for that event, or we may display team lists, or we may pass on other pertinent information. For example, during a Football game we might show information such as first downs, passing and rushing yards etc. In all instances these displays are indicative only and customers should not rely on such information to place a bet. Mount Airy Sportsbook will accept no responsibility for bets placed on their basis.

Types of Bet

There are many types of bets you can make within Mount Airy Sportsbook. See below for a comprehensive list, and the individual games sections to see what's on offer.

Straight Bet

A straight bet is a bet on the outcome of one selection in an event. Your selection must be successful to get a payout.

Parlays

A Parlay is a bet involving two or more (to a maximum of 16) selections you choose to win from different events. All selections must be successful to get a payout.

Round Robins

The Mount Airy Sportsbook will create all possible bet combinations for you - no matter how many picks you select (to a maximum of 10).

For example: If you make ten selections and want to combine them into all of the possible Six Selection Parlays, enter your bet amount in the Parlay bet slip and all of the possible combinations i.e. 210 Six Bet Parlays will be created as bets for you. In this example a 1-unit bet will cost you 210 units.

Teasers

A multi-event bet allowing the player to add or subtract points to improve the point Spreads or Totals selections. As an example, a player may be able to "tease" a pro football game from +2 to +8 (on a 6-point teaser).

Buying Points

Buying points allows you to change the point-spread or total of a football or basketball game. You can move the point-spread, so you get more points when betting the underdog or you give away fewer points when betting the favorite. When buying, Mount Airy Sportsbook charges 10 cents per ½ point. You can only buy points in Football and Basketball, both College and Professional.

There is a special rule when buying points on the spread in football:

- When buying on or off the 3 there is an extra cost of 15¢ (both NFL and College).
- When buying on or off the 7 there is an extra cost of 10¢ (both NFL and College).

Bet Acceptance

A bet is not valid until a bet ticket is printed. If there is an issue with the printing of a ticket from a betting kiosk the player is required to contact a Teller in the Sportsbook.

Once the player has left the Teller station or accepted the bet at a betting kiosk, the bet will remain valid and cannot be cancelled. It is the responsibility of the player to ensure details of the bets placed are correct. Under no circumstance will Mount Airy Sportsbook accept any responsibility for any mistakes (perceived and actual), deriving from either errors as listed under 'Errors' below, or any other reason, such as but not limited to, incorrect listing of the odds/betting objects.

Results and Bet Settlements

In the case of all sports, bets are settled on the official result published by the official governing body immediately after the game or event has finished. This may be referred to as 'weigh in' signal, 'podium presentation' or any similar terminology. Any subsequent correction or amendment to this result will not apply for settlement purposes.

Mount Airy Sportsbook reserves the right to apply a dead heat reduction on any event where more than one winner is specified, with individual sports having individual settlement rules.

Bets are settled at American odds.

Suspicious Betting

'Suspicious betting' refers to where we have reasonable grounds to believe that a single or number of bets have been placed in suspicious circumstances. This shall include, but not be limited to:

- Where there is an excessive frequency and/or highly unusual pattern of bets (when compared with betting norms) placed on the same selection(s) in a short space of time
- Where there is an excessive frequency and/or highly unusual pattern of bets placed on the same selection(s) and where the theoretical probability of said selection(s) winning at the time of bet(s) placement, based on the odds offered at the time of bet placement, is largely inconsistent with the theoretical probability of the same selection(s) winning calculated using their starting prices
- Where the integrity of one or more events has been called into question, including, but not limited to where one (or more) of the participants in an event displays exceptional form which we reasonably believe was known to you, or someone connected to you, at the time you placed the bet, and that information was concealed from the public generally in order to gain an unfair advantage in any bets placed on that event(s)
- Where we have reasonable grounds to suspect that a bet or a string of connected bets were not placed by you individually
- Where we reasonably believe you have used unfair external factors or influences connected with the event(s) the subject of any bet(s)
- Where we reasonably believe that you are acting in connection with others, or that you are acting other than on your own behalf.

In the case of any of the activities listed above, and without restricting our ability to rely on other remedies available, the following actions may be taken, depending on the circumstances:

- Request further information from you as may reasonably be required to investigate whether your actions constitute suspicious betting
- Withhold payment of any amounts (or any parts thereof) pending the receipt by us of satisfactory evidence from you that determines that a bet does not constitute a suspicious bet. For example where we suspect that bet(s) were made for another person we may require you to provide reasonable evidence that each bet was placed for yourself. You further acknowledge and accept that we reserve the right, at our sole discretion, to collect and process any information in connection with your betting patterns, personal data, depositing of funds and any other related information and inquiries that will help us to investigate any suspected breach of these Terms

- Withhold payment of any amounts (or any parts thereof), usually for no longer than 30 days, but where relevant for such longer period of time as may reasonably be required (for example - pending an investigation by Mount Airy Sportsbook, any sport's governing body, a gaming regulator, a law enforcement authority or any other third party)
- Void a bet(s), including parlays, prior to the event. Where possible, we shall communicate to you in advance that the bet(s) has (or have) been voided prior to the (first) event related to the bet(s);
- Calculate any winnings based on the starting price of the event(s) the subject of the bet(s). We shall communicate to you in advance that any bet(s) will be settled at the starting price, where possible
- Where there is an inordinate frequency and/or unusual pattern of Bets placed on the same selection(s) in a short space of time (and where we have reasonable grounds to suspect that the bets are connected bets) limit the payment of winnings to the equivalent of the Maximum Daily Payout and Maximum Ticket Payout limit permitted for a single customer.
- Where we have reasonable grounds to believe that you have participated in, or have been connected with, any type of suspicious betting, we shall use all reasonable avenues to investigate, including the use of various collusion, suspicious betting, fraud and cheating detection practices which are used in the gambling industry
- We reserve the right to restrict access to Mount Airy Sportsbook if we reasonably suspect any of the activities described in connection with your patronage of Mount Airy Sportsbook.
- Where a bet is deemed to be void (or is declared as void) by us prior to an event, any sum wagered with respect to that bet shall be refunded
- We reserve the right to seek to recover from you any losses we suffer that are directly or indirectly connected to suspicious betting practices. This right is without prejudice to any other rights (including common law rights) that we may have against you, whether under Terms of Use or otherwise
- We will not be liable under any circumstances whatsoever for any loss you or any other person
 may incur as a result of the behavior described in this section. We also reserve the right to take
 any other actions in the case of suspicious bets, but are not obliged to do so

As always, in exercising any of our rights we shall do so in a manner which is fair to you and to other Mount Airy Sportsbook patrons.

Mount Airy Sportsbook monitors irregular betting patterns and possible instances of event manipulation. If such betting behavior is identified, either solely by Mount Airy Sportsbook or in conjunction with third parties, Mount Airy Sportsbook reserves the right, in its absolute discretion, to: (i) suspend the offering of any event or series of events in any of its bet; and

(ii) delay and/or withhold payment on any event or series of events in any of its bet, until the integrity of such event or series of events has been confirmed by the relevant sports federation.

Furthermore, in the case of active event manipulation being confirmed as having taken place on any event or series of events in conjunction with the appropriate sports governing bodies, Mount Airy Sportsbook reserves the right, in its absolute discretion, to suspend any bets placed on such events, either by any individual as having possessed insider betting knowledge or information or by any other individual who in the reasonable opinion of Mount Airy Sportsbook is connected to, acting in conjunction with or in any way involved with such individual.

Prize Payment Procedure

Once the result of an event or a bet has been determined then all bets are settled immediately. Any prizes (winnings) due to customers will be paid out in the normal manner.

Bet Cancellation

Where a bet or selection is declared void, it will be settled with the odds of 1.00. An accumulative bet shall remain valid notwithstanding a selection from a game or an event which is part of the accumulative bet being void.

Mount Airy Sportsbook reserves the right, at its own discretion and subject to PGCB approval, to declare a bet void, totally or partly, in the obvious case of errors, or rigging. Bets can be voided regardless of whether the event has been settled or not. Furthermore, all bets placed (and/or accepted) in the following circumstances will be declared void:

Pre-game betting

- Betting effected after the event has started
- Betting effected after a related event was underway and where conditions have been altered in a direct and indisputable way

Live or In-Game Betting

- o Betting effected at incorrect price due to delayed or failing 'Live' coverage;
- Betting effected on particular offers after these have occurred, or else after an event which could normally be deemed as leading to the outcome has happened or is happening (e.g. bets placed on offers such as Total Goals Scored or Next Goal while a penalty is being taken, or has been awarded)
- Betting placed at on odds which represented a different score than the actual score at the time the bet was placed

Schedule Changes and Cancellation of Sporting Events

Where a bet has been placed on an event and that event is subject to a Schedule Change, all bets will stand so long as the venue has not been changed to the opponent's ground (or in the case of International games so long as the venue remains in the same country). However, Mount Airy Sportsbook reserves the right to void any bet where we feel that the Schedule Change has had a substantial impact on the betting for that game, according to the Sport's Specific rules.

The effect of schedule changes or cancellation of sporting events on betting opportunities varies by sport. See Sport's Specific individual rules below.

Related Contingencies

Parlay bets are not accepted where the outcome of one event contributes wholly or partially to the outcome of the other. Bets accepted in error will be settled at a special price (determined by Mount Airy Sportsbook) for all the outcomes to be successful.

For example: \$50 two selection parlay on the New England Patriots to beat the Pittsburgh Steelers with a points spread of -6.5 in the AFC Championship Game at -110 with the New England Patriots to qualify for the Super Bowl will be settled as a \$50 at -110 (If they have won the first leg they have qualified for the Super Bowl).

Similarly, if a parlay bet is placed on one team to win multiple events at individual prices (e.g. the New England Patriots to win the AFC Championship and the Super Bowl) we reserve the right to void such bets or to place them at a special price for the parlay

Errors

'Error' is a mistake, misprint, misinterpretation, mishearing, misreading, mistranslation, spelling mistake, technical hazard, registration error, transaction error, manifest error, force majeure and/or similar. Examples of errors include, but are not limited to:

- bets accepted during technical problems that would otherwise not have been accepted
- bets placed on events/offers that have already been decided

- bets on selections containing incorrect participants
- bets placed at odds that are materially different from those available in the general selection at the time the bet was placed
- bets offered at odds which reflect an incorrect score situation
- odds being clearly incorrect given the chance of the event occurring at the time the bet was placed.
- incorrect settlement of a bet or bets
- incorrect allocation of Free Bets

Mount Airy Sportsbook reserves the right to void, subject to PGCB approval, any bet where a blatant error is made. Instances of blatant error include but are not limited to an error in publishing a price or a handicap (e.g. New England Patriots -6.5 is published as New England Patriots +6.5). In case of such errors we will endeavor to contact the customer prior to the start of the event. However, in the situation where it has not been possible to contact the customer, bets will be void. In the event that an error is discovered after a bet has been settled, Mount Airy Sportsbook reserves the right to void the bet(s) retrospectively.

In the case of incorrect settlements Mount Airy Sportsbook reserves the right to correct any error made and re-settle the bet correctly.

Collusion - Tampering

Where there is evidence of price, race, game or event tampering, Mount Airy Sportsbook reserve the right to withhold payment, pending the outcome of any subsequent investigation and ultimately to declare bets on that event as void.

Where evidence of tampering exists, or where there is evidence of a series of bets containing the same selections(s) having been placed by or for the same individual or by a syndicate of individuals, we reserve the right to require claims for payment to be submitted in writing to Mount Airy Sportsbook. In the event of an official enquiry in relation to suspicious betting activity surrounding an event we reserve the right to disclose confidential information to the sport's governing body or their representatives, on the conditions that they consent to keeping such information confidential

Non-Runners

Unless otherwise stated in the betting offer or in the individual rules governing each sport - the principle of 'all bets stand' ('all in run or not') will apply to all bets placed on Futures/Event Winner offers. Therefore, if a bet is placed on any selection that fails to participate for any reason, the bet will be lost if the betting event takes place.

Only in exceptional cases will bets be declared void such as:

- The event /tournament is cancelled or declared void.
- The venue is changed.
- The event/tournament is interrupted/postponed and started/restarted more than 72 hours after original start date.

Competitors with the Same Name

Where two or more competitors have the same surname and those competitors have not been identified by a first name, team (where applicable) or qualifying price, then the competitor with the lowest advertised price will be deemed the selection. In the event of two or more competitors being quoted at the lowest advertised price then bet amounts will be split between them.

Maximum Payouts

It is the customer's duty to stay within the limits mentioned hereafter. The limits apply to straight bets and parlay bets. Where a parlay bet has been placed which involves events with different maximum payouts then the lowest limit will be applicable.

All bets are subject to a maximum payout to any one customer (or as set out below, any group of related customers) in any one day irrespective of bet amounts, odds or number of winning lines as listed below. Other than as set out below a bet is accepted on the basis that it is the investment of one

customer. All maximum payout limits apply to one customer, or groups of customers acting together, who have placed bets containing the same selections, including where placed in a series of bets, at a range of prices, over a number of days or different channels. Should we believe that a number of bets have been placed this way, the total payment of all those bets combined will be limited to one single maximum payout. We reserve the right, in our discretion, to apply the following limits. All limits are quoted in US\$.

Individual Sports' Rules

For your chosen sport see in-depth betting rules on each sport offered by Mount Airy Sportsbook. These rules are based on existing industry standards.

Please Note: where an individual sport's rules differ to any general sports rules listed on here, those detailed on the sport's specific, individual rules section will take precedence.

Football

Schedule Change: The following is applicable to all Football games, including NFL, NCAA College Football, CFL and Arena Football.

Abandoned or postponed games are void unless rearranged and played in the same NFL weekly schedule (Thursday-Wednesday local stadium time), except for those bets that have already been determined at the time of abandonment or postponement.

If a game venue is changed, bets already placed will stand, providing the home team is still designated as such. If the home and away team for a listed game are reversed, then bets placed based on the original listing will be void.

In 2-Way bets Push rules apply, unless otherwise stated. Bets on straight bets are returned, and in parlays the selection is treated as a non-runner. For example - in Handicap or Totals betting where the index (value) of the bet is a whole number, bets are void and will be refunded where the score lands on that number.

All settlements are based on results and statistics provided by the relevant league's governing body:

We reserve the right to suspend any or all betting on a game at any time without notice. For settlement purposes, the team listed first in the event name is always considered the Home Team. Example: Team A vs Team B - Team A is the Home Team.

Overview of Specific Markets

Live/In-Game Betting

For Live Betting purposes these rules apply unless stated otherwise.

• Where a Handicap Draw selection (3-Way Handicap market) is offered during live betting, only bets placed on the draw will be finalized as winners when the result lands on the whole number selected.

Prices quoted are for the whole game inclusive of any overtime played unless otherwise stated. As the markets are in-running, we reserve the right to close the market at any time.

- When scores are displayed in running, every effort is made to ensure the accuracy of the score and game time; however, no liability is accepted for incorrect information displayed.
- Next Score betting includes overtime.

Proposition bets

In the event of an abandoned game all bet amounts are returned, unless a result is already determined through the course of play that has taken place.

For player prop markets the player(s) in question must compete in at least one down to have action. All proposition bets are straight bets only. Overtime counts, unless otherwise stated.

Team Total Offensive Yards - Settlement is based on the net yards for both teams (includes sack yardage lost).

Team/Player Passing Yards – Settlement is based on gross passing yards.

Team/Player Rushing Yards – Settlement is based on the total rushing yards gained (includes negative yardage).

Quarterback props are based on gross passing yards gained.

To convert a 4th down attempt - The 'Yes' option is determined by achieving a new set of downs, either by run, pass (this includes if a TD is scored as a result) or automatic 1st down penalty. Field goals (irrespective of being made or not) do not count as a converted down.

Quarter and half markets

For bets based on the specific quarters or halves, the entire period of play must be played unless the result is already determined. NFL fourth quarter betting includes overtime.

Handicap Betting

Overtime counts for game handicap betting. Overtime does not count for quarter and half-specific markets, except NFL fourth quarter betting. For quarter and half betting, the entire period must be played for bets to stand. In the event of a tie, bets are refunded.

Game betting

Overtime counts, except for Double Chance betting, In the event of a tie following overtime all bets are refunded.

Total points

Overtime counts for all total game/team total and prop points markets. Overtime does not count for total points on quarter and half-specific markets, except NFL fourth quarter betting.

For quarter and half betting, the entire period must be played for bets to stand. In the event of total points being exactly the nominated line, all bets are refunded unless a price for the exact amount is quoted.

First offensive play yard line

The result is determined by where the first offensive play from scrimmage takes place. In the event of the kick-off being returned for a touchdown bets stand for the following kick off.

In the event of a turnover the result is determined on where the first offensive play takes place from, with respect to the receiving team's yard line.

First turnover and first team to commit a turnover

For results purposes, only an interception or a fumble counts. A punt or 'turnover on downs' does not qualify as a turnover for settlement purposes.

In the event of an abandoned game bets are returned, unless a turnover has already taken place.

First offensive play

In the event of a false start penalty on the first offensive play, bets stand for the next offensive play that takes place without a false start penalty.

First team/last team to score

In the event of an abandoned game, bets stand on scores that have taken place already. Overtime counts for these markets.

First/Last/Anytime Touchdown scorer

Forecast the name of the first/last/anytime Touchdown scorer in the game, or whether no touchdown will be scored. Only when a player is listed on NFL.com as 'inactive' for that game are the selections voided. 'The field' refers to any player not specifically listed. If no Touchdowns are scored, bet amounts will be lost unless 'no Touchdown scorer' is selected.

Will Either Team Score 3 Unanswered Times?

Forecast whether either team will score 3 consecutive unanswered times during the game. A Score excludes any PATs (point after touchdown or 2-point conversions).

Total Game Touchdowns/Field Goals

Predict the total number of Touchdowns/successful field goals in the game. Overtime counts.

Will there be Overtime?

Predict whether or not there will be overtime. If a game is abandoned prior to the end of normal playing time (regulation) bets are void, unless it is the final of the competition in which case all bets stand for the rescheduled game.

Will there be a safety?

Predict whether or not there will be a safety in the game. Overtime counts. A safety will be awarded by the game officials and is the only means whereby a team not in possession can score points. It can occur in a variety of ways but the most common is when an opponent in possession of the ball is tackled in his own end zone.

Super Bowl MVP

Predict which player will be voted the Most Valuable Player in the Super Bowl. For Super Bowl MVP propositions, if there are co-MVPs, any bet related would be paid at full odds.

Longest/Shortest Touchdown Markets

Shortest Touchdown Scored, Fumble recovered in end zone, under is a winner. If there are no Touchdowns, then bets are void.

Longest/Shortest Field Goal Markets

If there are no successful Field Goals, then bets are void.

Winning Margin

Predict the team to win the game and the margin.

Futures

All Futures markets include playoffs where applicable.

Super Bowl winner, Conference Outright and Divisional Futures bets stand regardless of the length of the season.

NFL Conference Winner

The team that progresses to the Super Bowl will be deemed the winner of the conference. NFL Divisional winner markets are determined by games won during the Regular Season (where appropriate NFL tie-break rules will apply).

NFL Draft: 1st Round Pick - Offense/Defense

Bets will be void where a Team trades their pick. Affects this market only – all other NFL Draft markets are unaffected.

Athletics

The following is applicable to all Olympic, World, European and all other Championships betting.

Schedule Change: If a track or field event is cancelled for any reason prior to the event, then all bets will be void.

In Futures betting opportunities all bets shall stand irrespective of whether the athlete competes or not (all in run or not). If an athlete withdraws before they have taken part in the event, the bet will be a loser.

Diamond League events

In Futures betting opportunities, a rule 4 deduction may apply to withdrawals. If an athlete withdraws before they have taken part, stakes on that athlete will be void.

Head-to-Head betting

Both athletes must start an event, or all bets will be void.

Group Betting

In the event of any athlete failing to take part, all subsequent group bets will be made void.

Finalizing of bets

All bets will be finalized on the medal ceremony regardless of any subsequent disqualification. If there is no podium ceremony, finalizing of bets will be based on the result declared by the official International Association of Athletics Federation (I.A.A.F) immediately after the event, irrespective of any subsequent enquiry.

Winning Time/Distance

Finalized as per the result listed by the governing body (IAAF).

Nationality of Winner

This is determined by the country the winner competes for (not the country they were born in if there is a difference).

Australian Rules

Schedule Change: If a game venue is altered, then bets already placed on the game will stand so long as the home team is still designated as such. If the home and away team for a listed game are reversed, then all bets placed based on the original game will be made void.

All game bets will be finalized including overtime if played unless otherwise stated. The entire length of regulation time must be completed for bets to stand unless specifically otherwise stated. If the length of a game is altered before play commences then the revised game length time will be regarded as the official game length and all bets will stand as long as this new regulation time is entirely completed.

Badminton

Schedule Change: All bets will stand irrespective of a change of schedule (or day of game), or a Schedule Change. All bets will be void in the event of a game starting but not being completed, except for bets where the outcome has already been determined, or where there is no conceivable way the game and/or game could be played to its natural conclusion without unconditionally determining the result of a specific bet. For example: a game is abandoned at 19-17. Bets on over/under 36.5 Game Total Points are settled as winner and losers respectively since any natural conclusion to the game would have resulted in at least 38 points.

In-Game Point Betting is offered for a player to win the nominated point. In the event of the point not being played, due to the game or game ending, all bets on that point will be void. If the nominated point is awarded as a penalty point, all bets on that point will be void.

Current/Next Set Leader After: If the quoted number of points is not reached in the specified set, then the team/player who wins the set will be finalized as the winner.

Finalizing of Bets

Results provided by the official score provider, or the official website of the relevant competition or fixture, will be used to finalize bets. Where these are not available, or there is significant evidence that the official scores provided are incorrect, we will use independent evidence to support a bet being finalized. In the absence of consistent, independent evidence, or in the presence of significant conflicting evidence, bets will be finalized based on our own statistics.

Bandy

All bets are settled on 90 minutes play unless otherwise stated. If a game is not completed, then bets will be void unless an official result is declared.

If the format of a game is changed for whatever reason from 2 x 45 minutes to 3 x 30 minutes, then all bets will stand (except any bets that relate specifically to first/second half).

Baseball

Schedule Change: All games must start on the scheduled date (local time) for bets to have action. If a game has been postponed or cancelled before its due start time, then all bets are deemed no action.

For non-MLB Baseball (including Minor League Baseball) games, or MLB pre-season games with no named pitcher, no listed pitchers and all bets are action regardless of who pitches for each team. The 8½ innings rule also applies, although in the event of a Mercy Rule being called, all bets will stand on the score at the time. For seven innings games played as part of a doubleheader the 6½ inning rule will apply.

In 2-Way bets Push rules apply, unless otherwise stated. Bets on straight bets are returned, and in multiples/parlays the selection is treated as a non-runner.

If a game venue is changed then bets already placed will stand, providing the home team is still designated as such. If the home and away team for a listed game are reversed, then bets placed based on the original listing will be void.

Settlement of Bets

All settlements are based on the results and statistics provided by the relevant leagues governing body, for example - MLB (Major League Baseball).

MLB Bets

It is the player's responsibility to ensure they are aware of any relevant pitcher changes.

- **Listed Pitchers Must Start** A bet that specifies both starting pitchers. Any variation constitutes no action. Bets that were placed when the named pitcher was originally listed are no action if the listed pitcher is changed and is then re-listed back to the original pitcher.
- No (Starting) Pitchers named Team against Team regardless of starting pitcher. Bets are action.

Bets placed on the named pitcher, after being re-listed, are action. Double pitching change, where a listed pitcher is changed then re-instated for betting purposes, bets will be treated as a normal pitching change.

For Baseball and unless otherwise specified, if a match is suspended/postponed and is continued within 48 hours of the previous scheduled start time, then all bets will be considered "action" and settled with the final result. If the match is not started within 48 hours, then all undecided bets are considered "no action/void." unless stipulated otherwise on guest wagering information sheets or odds display.

Games Not Played as Listed

If a game venue is changed then bets already placed will stand, providing the home team is still designated as such. If the home and away team for a listed game are reversed, then bets placed based on the original listing will be void.

4½ Innings Rule

Money Line - There must be at least five full innings of play, unless the team batting second is leading after $4\frac{1}{2}$ innings, for bets to stand. If the game is called, or suspended, after this point of the game is reached, then the winner is determined by the score after the last full inning (unless the team batting second scores to tie, or takes the lead in the bottom half of the inning, in which case the winner is determined by the score at the time the game is called).

Please note that suspended games do not carry over (with the exception of MLB play-off games). However, in the event of a Mercy Rule being called, all bets will stand on the score at the time.

61/2 Innings Rule

Total and Run Line betting (for seven innings games) - The game must go at least seven full innings (or 6½ innings if the team batting second is ahead) for bets to have action. However, in the event of a Mercy Rule being called, all bets will stand on the score at the time. Please note that suspended games do not carry over.

8½ Innings Rule

Total and Run Line betting - The game must go at least nine full innings (or 8½ innings if the team batting second is ahead) for bets to have action. However, in the event of a Mercy Rule being called, all bets will stand on the score at the time. Please note that suspended games do not carry over (with the exception of MLB play-off games).

Pre-Game Lines

- All pre-game bets include extra innings, unless otherwise stated.
- Where Mercy Rule is applied, all bets will stand on score at the time.
- Money Line: Finalized as per the 4½ innings rule (see above).
- Run Line, 3-Way Handicaps and Alternative Run Lines: Finalized as per the 8 ½ innings rule (see above).
- Game Total, Team Totals, 3-Way Totals and Alternative Game Totals: Finalized as per the 8 ½ innings rule, with the exception of when a result has already been determined.
- Most Hits, Total Hits, Team Hits: Finalized as per the 8½ innings rule, with the exception of when
 the total has already gone over; where bets on the over will be Finalized as winners, and bets on
 the under finalized as losers.
- 4½ Innings Totals Bets will be finalized based on the score in the middle of the 5th inning (e.g. not at the bottom of the 5th), unless the Total quoted has already gone over. Where this occurs, all bets will be finalized as follows over bets on quoted Total will be finalized as winners, with under bets on quoted Total being finalized as losers.
- 4½ Innings Lines Bets will be finalized based on the score in the middle of the 5th inning (e.g. not at the bottom of the 5th), unless the team batting first is ahead (with any run line applied) at the start of the top of the 5th innings or score to go ahead (with any run line applied) in that inning, in which case the team batting first will be finalized as the winner.
- 3/5/7 Innings Totals Bets will be finalized based on the score after 3/5/7 full innings, unless the
 total quoted has already gone over quoted total. Where this occurs, all bets will be finalized as
 follows over bets on quoted total will be finalized as winners, with under bets on quoted total being
 finalized as losers.
- 3/5/7 Innings Line Bets will be finalized on the result after the first 3/5/7 innings of a game have been completed, unless the team batting second is already ahead (with any run line applied) at the middle of the relevant inning, or scores to go ahead (with any run line applied) in that inning, in which case the team batting second will be finalized as the winner.

Pre-Game Props Including Player Props

Where Mercy Rule is applied, all bets will stand on score at the time.

- Listed pitchers must start for bet to have action. Extra innings count, unless specified otherwise.
- All 1st Innings Props 1st inning must be completed for bets to have action, unless settlement of bets is already determined.
- Double Result Finalized on the score at the end of the 5th inning plus the final score are per the 8 ½ innings rule
- Odd/Even Bets Finalized as per the 8 ½ innings rule. In the event of a result of zero is arrived at, that shall be considered an even number for settlement purposes
- Total Runs Finalized as per the 8 ½ innings rule with the exception of when a result has already been determined.
- Lead After x Innings Bets will be finalized on the result after the first x innings have been completed, unless the team batting second is already ahead at the middle of the relevant inning,

- or scores to go ahead in that inning, in which case the team batting second will be finalized as the winner.
- First to Score/Race to x Runs The first team to reach the required number of runs will be finalized as the winner. Bets on Neither require the 8½ innings rule to apply to be finalized as winners.
- Last to Score Finalized as per the 8 ½ innings rule.
- Team with Highest Scoring Innings Will be finalized on the single highest scoring half-inning of the game. If both teams have the same highest score, then Tie will be finalized as the winner (even if one team has attained this score more often than the other). 8½ innings rule also applies.
- Extra Innings Yes/No Will be finalized as Yes if the score is tied after 9 innings (or the statutory number of innings if this is not 9), even if later innings are not played for any reason.
- When Will Most Runs Be Scored? Finalized as per the 8 ½ innings rule.
- First HR Will Be? Will be finalized on the first HR hit in the game. Bets on "No HR" require the 8½ innings rule to apply to be finalized as winners.
- Match-ups: Most (Total) Bases*/Most Hits/Most Strikeouts For these match-ups to have action both players must be in official starting line-up. 8½ innings rule applies, unless both players, or the player losing the match-up, have already been substituted out of the game. Both listed pitchers (at time of placing bet) must start for bets to have action.
- Player Performance: (Total Bases*/Total Hits/Total Strikeouts/To Hit a HR/Record a Walk/Record an RBI/Score a Run). The player must be in the official starting line-up and the opposing listed pitcher (at time of placing bet) must start for bets to have action. 8½ innings rule applies, unless settlement of bets is already determined, either by the player achieving the required outcome or by being substituted out of the game without having done so.
- *Total Bases are calculated by adding all hits a player makes as per Single = 1 Base, Double = 2, Triple = 3, Home Run = 4. Only these count.
- Starting Pitcher Completed Innings Pitcher must start for bets to have action. Bets will be finalized
 based on the number of full innings that the starting pitcher pitches. Bets will be void if the game is
 called or suspended with the starting pitcher still in the game and not yet having reached the
 required number of innings.

MLB Odds Boosts/Super Boosts:

All Odds Boosts and Super Boosts will always exclude MLB 'Write in Games'. These are games
that are not on the original schedule and thus will never be considered for any promotional offer or
boosted price given to customers.

Grand Salami (Total Runs and Away Runs vs Home Runs):

- Grand Salami bets will be decided by the total runs scored in all games of the specific league scheduled for that day.
- All scheduled games must go at least nine full innings (or 8½ innings if the team batting second is ahead) for bets on Grand Salami to have action and be completed on its scheduled day (games can finish past midnight if started before).
- For the Grand Salami bets (Total Runs and Away Runs vs Home Runs), the home team runs will be the runs scored by the teams batting second in the first inning. On rare occasions, a team batting second will not be playing at their home stadium. In these instances, the team batting second will still be considered as a home team for these bets.

In-Game

Where Mercy Rule is applied, all bets will stand on score at the time.

- All bets are action regardless of pitching changes. Extra innings count, unless stated otherwise.
- Money Line Finalized as per the 4½ innings rule.
- Run Line/Alternative Handicap Finalized as per the 8 ½ innings rule
- Game Total, Team Totals, 3-Way Totals and Alternative Game Totals Finalized as per the 8 ½ innings rule with the exception of when a result has already been determined.
- 3-Way Handicap Includes Handicap Tie price. Extra innings count. Subject to 8½ innings rule.

- To Go To Extra Innings The end of the 9th inning must be complete for bets to have action. If the score is tied after nine innings then this bet will be finalized as Yes, even if the extra innings are not played due to the game being called/suspended.
- To Win Inning (Current/Next) Top and bottom of the specified inning must be completed unless the team batting second in the specified Inning is winning when the game is called/suspended.
- Inning Run Line (Including Alternatives) Top and bottom of the specified innings must be completed for bets to have action, unless the team batting second in the specified Inning has already covered the run line and cannot be overtaken.
- Inning Total (Including Alternatives) Top and bottom of the specified innings must be completed
 for bets to have action, unless the Total quoted has already gone over at the time the game is
 called/suspended.
- A Score in the Inning (Current/Next) Top and bottom of the specified inning must be completed, unless settlement of bets is already determined.
- A Score in 5 Inning/Hit in 5 Inning (Current/Next) Specified half inning (top or bottom) must be completed, unless a run has already been scored/hit has already occurred when the game is called/suspended.
- Team to have Most Hits in the Inning (Current/Next) Top and bottom of the specified inning must be completed for bets to have action, unless the team batting second in the specified inning has most hits when game is called/suspended.
- Total Hits in the Inning (Current/Next)/Total Runs in Inning (Current/Next) Top and bottom of the specified inning must be completed unless settlement has already been determined.
- Leader After 'X' Innings Top and bottom of the specified inning must be completed for bets to have action, unless team batting second leads and cannot be overtaken at time the game is called/suspended. In the event of a Mercy Rule being applied, any uncompleted innings leader bets will be deemed to have been won by the game winner.
- Race to Bets/Team Totals/Total Hits 8½ innings rule applies, unless settlement of bets is already determined, or if the natural conclusion of the game would have meant the outcome of bets would be determined.
- If a tied game is called or suspended, and the natural conclusion of a game requires a winner, then bets on the relevant Race to Quote will be made void. For example a MLB game is called, or suspended, at 3-3 after 10 innings. In this instance, all bets on Race to 4 will be void. Race to 5/6/7 bets would be finalized as 'Neither'.
- Team to Score Next In the event that the game is abandoned all bets on runs already scored will stand. Bets on the next run at time the game is called/suspended will be no action.
- Winning Margin Subject to 8½ innings rule. Settlement includes extra innings for MLB; for non-MLB where a game can end in a Tie, then that option is available. If an MLB game ends in a tie when a game is called/suspended, then bets will be void.

Futures - General Rules

Series Betting

Bets are void if the statutory number of games (according to the respective governing organizations) are not completed or are changed.

Futures. Pennant and Divisional Betting

All bets stand regardless of team relocation, team name change, and season length or playoff format.

To Win American League or National League

The teams that progress to the World Series will be deemed the winners.

Wildcard Betting

A team that progresses to the MLB Playoffs via a wildcard position will be deemed a inner.

Bet Bundle

If no starting pitchers are named, bets are actioned regardless of starting pitcher changes.

Pesapallo

For settlement purposes extra innings count. If a game is postponed or cancelled before its scheduled start time, then all bets on the game will be made void.

Basketball

Schedule Change: The following is applicable to non-NBA/NCAA Basketball events (FIBA tournaments, European, Australian, Central American, South American and Asian Basketball competitions).

Any un-played or postponed game will be treated as a non-runner for settlement purposes, unless it is played within 36 hours of the initial scheduled starting time.

In the event of a game starting but not being completed then all bets will be void, except for those where the outcome has already been determined. For example - if a game is abandoned at 104-100 with five minutes left on the clock. In this instance the bets on over 203.5 points will be deemed the winner for settling purposes.

The following is applicable to NBA/NCAA Basketball events.

All games must take place on the same day local time for bets to stand. Should a game be called off with more than five minutes to play then all bets will be void, except for those where the outcome has already been determined. For example - a game is abandoned at 104-100 with five minutes left on the clock. In this instance the bets on over 203.5 points will be deemed the winner for settling purposes.

NBA/NCAA Basketball Game and Prop Betting

All games must start on the scheduled date (local stadium time) for bets to have action. If a game venue is changed, bets already placed will stand providing the home team is still designated as such. If the home and away team for a listed game play the fixture at the away team venue then bets will stand providing the home team is still officially designated as such, otherwise bets will be void.

There must be five minutes or less of scheduled game time left for bets to have action, unless the specific bet outcome is already determined.

In 2-Way bets, Push rules apply, unless otherwise stated. Bets on straight bets are returned, and in parlays the selection is treated as a non-runner.

Pre-Game Bets, Including Game Props

All pre-game bets include overtime, unless otherwise stated. Fourth quarter betting does not include overtime.

Player Match-Ups/Performances

Betting is available on the performance of a named player in a variety of achievements e.g. points, rebounds, assists, blocks, free throws. Push rules apply.

Relevant players must be dressed and see court-time for bets to have action. Overtime counts for any player props, unless specified otherwise.

Individual player's performances are matched for betting purposes in a player match-up. Handicaps may be used and are applied to each player's actual score to determine the result. Push rules apply. With regards to Double Double/Triple Double bets, the following applies:

- Double/Double player must record 10 or more in two or more of the following 5 statistical categories: points, rebounds, assists, blocked shots, steals
- Triple/Double player must record 10 or more in 3 or more of the following 5 statistical categories: points, rebounds, assists, blocked shots, steals

In-Game Bets INCLUDE Overtime

If a game is postponed or cancelled after the start, there must be five minutes or less of scheduled game time left for bets to have action.

In-Game Half Bets INCLUDE Overtime

The first half must be completed for first half bets to stand. If a game is postponed or cancelled after the start, for game and second half bets there must be five minutes or less remaining for bets to have action, unless settlement of bets is already determined.

In-Game Quarter Bets DO NOT INCLUDE Overtime

The quarter must be completed for bets to have action, unless settlement of bets is already determined. Bets on the 4th quarter will not include any overtime played.

NBA Futures/Tournament Props

- Regular Season Wins/Match-Ups Team must complete at least 75 regular season games for bets to have action unless the remaining games during the course of the season do not affect the result.
- To Win Division NBA tie-break rules apply. Playoffs do not apply.
- To Win Conference The team that progresses to the NBA finals will be deemed the winner of the conference.
- Settlement of all bets will be determined by official rankings and statistics provided by tournament governing bodies such as the NBA, FIBA.
- Furthest Progressing Team and Stage of Elimination The highest official ranking (provided by the tournament governing body) will be used for settlement except when teams are eliminated at the same stage and no ranking is available to distinguish settlement - in which case bets will be void.
- NBA Scoring Title Title is awarded to the player with the highest points per game average in a
 given season. To qualify for the scoring title, the player must appear in at least 70 games (out of
 82) or have at least 1,400 points
- NBA Rebounding Title Title is awarded to the player with the highest rebounds per game average
 in a given season. To qualify for the rebounding title, a player must appear in at least 70 games
 (out of 82) or have at least 800 rebounds.
- NBA Assist Title Title is awarded to the player with the highest assists per game average in a
 given season. To qualify for the assist title, the player must appear in at least 70 games (out of 82)
 or have at least 400 assists

Outright, Division, Conference and Regional Betting

All bets stand regardless of team relocation, team name change or season length.

Series Betting

Bets are void if the statutory number of games (as stipulated by the respective governing organization) are not completed or are changed.

First Basket Bets

Result based on the first score of the game, inclusive of free throws. Should a player not start the game, all bets on said player will be void, otherwise betting is all-in.

Settlement of Bets

Statistics provided by the official score(s) provider or the official website of the relevant competition or fixture will be used to finalize bets. Where statistics from an official score(s) provider or official website are not available or there is significant evidence that the official score(s) provider or official website is incorrect, we will use independent evidence to support bet settlement.

In the absence of consistent, independent evidence or in the presence of significant conflicting evidence, bets will be settled based on our own statistics.

All Basketball (Excluding NBA/NCAA)

Overtime counts for all bets, unless otherwise stated, as well as the following:

- 3-Way and Double Chance bets do not include Overtime
- For player performance betting, player(s) must compete in the game to have action. Overtime counts for player performance betting.
- In 2-Way bets, Push rules apply

 Whenever there is a home and away game (with an aggregate points scored based format) full game bets will be settled according to the regular time result, and any overtime will not count (unless both games finish in a draw after regular time).

Beach Soccer

Schedule Change: Beach soccer games must be completed or else all bets are considered void, unless unconditionally determined.

Any postponed or cancelled games will be treated as a non-runner for settling purposes, unless it is played within 48 hours of the original start time.

Beach Volleyball

Schedule Change: When a game venue is changed bets already placed will stand, but only when the home team is still designated as such and the game is not instead played at the away team venue, otherwise bets will be void.

Postponed or cancelled games will be treated as a non-runner for settling purposes, unless played within 48 hours of the original start time.

Statistics provided by the official score provider, or the official website of the relevant competition will be used to finalize bets. If a game starts but is not completed, then all bets will be void apart from those which have been unconditionally determined.

On all bets in the event of referee enforced point deductions, official results will be used for settlement purposes.

When a Golden Set is used to decide which team progresses for competitions with two-legged ties (in the event of the tie being tied in games won), the Golden Set does not count for settlement purposes.

Bowls

Schedule Change: If a match does not take place for any reason (e.g. injury withdrawal) all prematch bets will be void and bet amounts returned. In the event of a match starting but failing to be completed then the player progressing to the next round will be deemed the winner.

Futures

For any Futures bets, bets will be finalized in an 'all-in run or not' basis (no refunds for non-starters).

Game Betting

In the event of a game starting but failing to be completed then game bets will be void. In this case, all other bets will be void unless their result has already been unequivocally decided.

To win nth End

In the event of an end being judged a draw then all bets will be deemed void.

Settlement of Bets

Statistics provided by the official website score provider or the official website of the relevant competition or fixture will be used for the settlement of bets. Where statistics from an official score provider or official website are not available, or there is significant evidence that the official score provider or official website is incorrect, we will use independent evidence to support our bet settlement. In the absence of consistent, independent evidence or in the presence of significant conflicting evidence, bets will be finalized based on our own statistics.

Boxing & MAA

Boxing

Schedule Change: Game bets where no draw selection is offered will be made void if game ends a draw.

Should the fight be postponed bets will be void unless it is rescheduled within 48 hours to take place within 30 days of the original date.

Later fight announcements made in regard to result changes, post-fight enquiries or changes to the official result in hindsight won't affect the original event settlement.

Should there be a change in the advertised contest (for example, a contest changes from a title fight to a non-title fight) bets will stand.

In fights where the scheduled number of rounds changes, all bets stand unless result is predetermined. For example, if a fight gets changed from the 12 to a 10-rounder, bets on round 11 and 12 will be void.

Results will be settled on the official result from the judges at ringside on the night, with the exceptions being those of a Technical Draw (TD) or No Contest (NC). Should a TD or NC be announced given an accidental injury within the first four rounds forcing an early stoppage of the fight, then all bets will be settled as void unless the result has already been determined.

In the event of a wrong result being called out in error, bets will be settled on the corrected result.

Total Rounds

For the settlement purposes of Total Rounds bets, where half a round is stated, 1 minute 30 seconds of the respective round of a fight will determine over/under. If the number of rounds for a fight is changed after this bet has been set, then all bets will be void.

Round Betting

If a fighter withdraws in the period between rounds the fight is deemed to have ended in the previous round for the purpose of 'Round Betting' settlement.

Should the scheduled number of rounds be changed before the fight all 'Round Betting' bets will be voided.

Mixed Martial Arts & UFC

Schedule Change: Should the fight be postponed bets will be void unless it is rescheduled within 48 hours to take place within 30 days of the original date.

Results will be finalized on the official result from the judges at ringside on the night. Later fight announcements made in regard to result changes, post-fight enquiries or changes to the official result in hindsight won't affect the original event settlement.

In the event of a wrong result being called out in error, bets will be finalized on the corrected result.

To Win the Fight

Prices are offered for each fighter to win the fight and in the event of a draw all bets will be void and bet amounts returned. This includes a fight which ends in a 'majority draw'.

Total Rounds

For the settlement purposes of the Total Rounds bets, where half a round is stated, 2 minute 30 seconds of the respective round of a fight will determine over/under. If the number of rounds for a fight is changed after this bet has been set, then all bets will be void.

Round Betting

If a fighter withdraws in the period between rounds the fight is deemed to have ended in the previous round for the purpose of 'Round Betting' settlement.

Should the scheduled number of rounds be changed before the fight all 'Round Betting' bets will be made void.

Cricket

Schedule Change: If a match is cancelled before any play has taken place, then all bets are considered void, unless the match is restarted within 48 hours of its initial starting time.

If a match venue is changed then bets already placed will stand providing the home team is still designated as such. If the home and away team for a listed match are reversed, then bets placed based on the original listing will be void.

All bets do not consider super overs unless otherwise mentioned.

Penalty runs are not considered in any over or delivery bets (bets for parlay overs are not considered for this rule)

If a match is cancelled before any play has taken place, then all bets are considered void, unless the match is restarted within 48 hours of its initial starting time. If the match is tied and the official competition rules do not determine a winner, or if the competition rules determine the winner by a coin toss or drawing of lots, then all undecided bets are considered void. In the event of an over not being completed, all undecided bets on this specific over are considered void, unless the innings has reached its natural conclusion e.g. declaration, team all out, etc. If bets remain open with an incorrect score which has a significant impact on the prices, we reserve the right to void betting.

Twenty20 Cricket

All scheduled overs must be played for undecided bets to be finalized, unless the innings has reached its natural conclusion.

ODI Cricket

A minimum of 90% of the entire overs allocated for an innings must be played for bets to be finalized, unless the innings has reached its natural conclusion.

Match Betting

In Twenty20 cricket, matches affected by adverse weather bets will be governed by the official competition rules. Where no price is quoted for the tie and the official competition rules determine a winner/progressing side, bets will be finalized on the official result. If a match is abandoned due to outside interference, then bets will be void unless a winner is declared based on the official competition rules. In the event of a change of opponent from the one advertised all bets for that match are void.

In-Play Runs in First 'X' Overs

If the selected number of overs is not completed due to external factors then bets will be void, unless settlement of bet is already determined.

If the normal length of the innings is less than the selected number of overs (e.g. a team is all out in less than the selected overs or reaches their target) then bets will stand.

Team to have highest scoring over

If both teams do not complete the stated number of overs due to external factors or adverse weather then bets will be void, unless settlement is already determined. In the event of a tie, bets will be void.

Top Team Batsman

In a 2-innings match (Test Match or County Championship), this bet applies to the first innings only, unless otherwise stated.

Depending on the type of match the following minimum overs must be bowled in that team's innings for bets to stand:

- Test Matches 50 overs
- County Championship 50 overs
- 50 over match 25 overs
- 40 over match 20 overs
- 20 over match 15 overs

In all cases bets will stand if the innings reaches its natural conclusion in less than the above requirement. Bets placed on any player not named in the starting eleven are void.

Players named in the starting eleven that do not bat are deemed to have taken part and bets on any such players are losers.

If players score the same number of runs, then dead heat rules apply.

Top Team Bowler

In a 2-innings match (Test Match or County Championship), this bet applies to the first innings only, unless otherwise stated.

Depending on the type of match the following minimum overs must be bowled in that team's innings for bets to stand:

Test Matches - 50 overs

- County Championship 50 overs
- 50 over match 25 overs
- 40 over match 20 overs
- 20 over match 15 overs

In all cases bets will stand if the innings reaches its natural conclusion in less than the above requirement. Bets placed on any player not named in the starting eleven are void.

Players named in the starting eleven that do not bowl are deemed to have taken part and bets on any such players are losers.

In the event of players taking the same number of wickets, the winner will be determined as the bowler that has conceded the least number of runs, irrespective of overs bowled by each player. If it is still not possible to determine a winner, then dead heat rules apply.

Cycling

- a. All future book wagers on Cycling are "Action," unless stipulated otherwise on guest wagering information sheets or odds display.
- b. All participants in event match-up or Driver propositions must start the race, or that proposition is "No Action" and wager will be refunded.
- c. The winner of driver matchups and race propositions will be based on the official finish order.
- d. All auto race and cycling wagers are on cyclists only; not on a team unless stipulated otherwise on guest wagering information sheets or odds display.
- Race results will be considered official for wagering purposes upon conclusion of post-race inspection. At that time auto series recognized results and statistics will be used to determine all winners and losers. Subsequent changes will not be recognized.
- f. The field includes any cyclist who is not listed.
- g. If a specific event is suspended/postponed, then bets will be considered "action" provided that the event is completed within 72 Hours.

Futures Betting (includes individual jersey/classification winners)

Unless otherwise stated, betting is on an 'all-in run or not' basis (no refunds for non-starters). Settlement of bets will be determined by the official final result on the last day of the tour. Any subsequent disqualifications will be ignored for settlement purposes.

Futures Head-To-Heads

Ante post head-to-heads will be finalized upon the cyclist achieving the highest placing in the specified event as listed in the official results. Both riders must start for bets to stand. Settlement of bets will be determined by the official final results declared on the last day of the event. Any subsequent disqualifications will be ignored for settlement purposes.

Individual Stage betting

All stage betting is 'all-in run or not'. All bets are finalized on the governing bodies official classification listings, at the time of the podium presentation. Any subsequent disqualifications will be ignored for settlement purposes.

Individual Rider To Win/ Top 3 Yes/No betting

We occasionally offer outright betting markets for a race or stage where there is a 'yes/no' option for a named rider to win/finish in top 3. In the event of a dead heat on these markets - where both sides could be deemed as winners - markets will be declared void.

Stage Head-to-Heads

Game bets will be finalized on the rider achieving the best finishing position. Both riders must start a stage for bets to stand. Should just one rider finish, he will be deemed the winner. Should both riders fail to finish, bets on both riders will be made void.

Stage Winning Margin

All bets are finalized on the governing body's official time margin at the time of the podium presentation.

To win any Stage

This bet may be offered on Grand Tour events (Tour de France, Giro d'Italia and Vuelta a Espana). All Stages will count for settlement purposes, with the exception of Team Time Trials.

Darts

Schedule Change: In the event of a match starting but not being completed, the player progressing to the next round or being awarded the victory will be deemed the winner for settlement purposes. Bets will be void in the 2-Way Match Result bet if the match result is a tie.

Floorball

Schedule Change: All games must start on the scheduled date for bets to have action. If a game has been cancelled or postponed before its scheduled start time or is not completed in full in accordance with regulation time, then all bets will be deemed void. All game bets will be settled on the score at the end of regulation time and will exclude overtime if played, unless stated otherwise. If a game venue is changed then bets already placed will stand providing the home team is still designated as such. In the event of the home and away team for a listed game being reversed (swap of venue) then bets placed based on the original listing will be void.

Soccer

Schedule Change: Any unplayed or postponed game will be treated as a non-runner for settling purposes, unless we can establish within a reasonable time frame - using publicly available information from governing bodies - that the game has been rescheduled within three days of the original start time in which case the bet will stand.

Any bets on a game abandoned before the completion of 90-mins will be void except for those bets where the outcome has already been determined. For example - if a game is 5-2 and is abandoned with 10 minutes left to play then over 6.5 goals will be settled as a winner, and under 7 goals settled as a loser.

Where a game is played at a venue other than the venue listed then all bets will stand providing that the home team is still designated as such. If the home and away team are reversed - i.e. the away team is now the home team - then bets placed on the original listing will be void.

Futsal

Schedule Change: Should a game be abandoned before the end of regulation time then all bets will be declared void unless a definitive result for that bet has already been determined prior to abandonment, e.g. Team A to score goal 1.

A game must be played within 48 hours of the original scheduled start time for bets to stand. If a game doesn't take place for any reason within this period, bets will be deemed void.

Handball

Schedule Change: If/when a game venue is changed bets already placed will stand, providing the home team is still designated as such. If the home and away team for a listed game play the fixture at the away team venue bets will stand, providing the home team is still officially designated as such. In all other cases bets will be void.

Any postponed or cancelled games will be treated as a non-runner for settling purposes unless it is played within 48 hours of the original start time.

Golf

Schedule Change: If a tournament is shortened and Mount Airy Sportsbook settles the tournament bets, then all bets placed after the last completed round will be void. In addition, if a price for a tie is not available, dead heat rules will apply.

If a Tournament/Round is restarted from the beginning, all bets placed after the official off time will be void, except on bets which have been unconditionally determined. Bets on 2-balls or 3-balls will only be void if placed after the tee time of the relevant group.

If a player withdraws without playing a stroke all bets on the relevant bet will be void. Likewise, should all players within the framed bet fail to complete the first round then all bets will be void.

If a tournament is reduced in length because of adverse weather, then all bets will be settled providing a winner of the tournament is deemed and a minimum of 36 holes are completed. The winner will be the player in the lead at the end of the last completed round.

Hockey

Schedule Change: All games must start on the scheduled date (local stadium time) for bets to stand. If a game venue is changed, bets already placed will stand providing the home team is still designated as such. If the home and away team for a listed game play the fixture at the away team venue then bets will stand providing the home team is still officially designated as such, otherwise bets will be void.

There must be five minutes or less of scheduled game time left for bets to stand, unless the specific bet outcome is already determined.

Motorsports

- All future book wagers on Auto Racing are "Action," unless stipulated otherwise on guest wagering information sheets or odds display.
- All participants in event match-up or Driver propositions must start the race, or that proposition is "No Action" and wager will be refunded.
- The winner of driver matchups and race propositions will be based on the official finish order.
- All auto race wagers are on drivers only; not on a team or car, unless stipulated otherwise on guest wagering information sheets or odds display.
- Race results will be considered official for wagering purposes upon conclusion of post-race inspection. At that time auto series recognized results and statistics will be used to determine all winners and losers. Subsequent changes will not be recognized.
- The field includes any driver who is not listed.
- If a specific event is suspended/postponed, then bets will be considered "action" provided that the event is completed within 72 Hours.

Formula 1

Schedule Change: All race bets are settled on the official classification from the Federation Internationale de l'Automobile (FIA), the sport's governing body, at the time of the podium presentation.

In the event of a driver switching race teams during race week, or a driver not originally listed entering the field, all bets taken prior to these changes being factored into the betting will be re-settled at the correct price taking into account the team/car change. This is inclusive of all bets offered for F1. Our decision on this matter is final.

Nascar/Indy Car/Cart

Schedule Change: In Outright Race betting 'the field' includes any driver who is not listed in the outright prices. Any drivers who fail to qualify for the race will be deemed as non-runners. The race must be held within one week of the schedule race time for there to be action. The official NASCAR / INDY winner of the race will be settled as the winner for betting purposes, this includes all races which are halted prematurely.

Poker

Schedule Change: If a Tournament was abandoned or unable to complete for any reason, then Tournament winner bets will be declared void. Only bets where the result has already been determined will stand. For example, if a tournament is abandoned with 9-players remaining then bets on 'To Finish in The Top 9' will stand, but bets on 'To Finish in The Top 3' will be declared void.

If a Tournament does not take place, then all bets for that event will be declared void unless the tournament takes place within 48-hours of the originally scheduled starting time.

Any player starting the Tournament but who later withdraws, or is disqualified before the ends, will be settled as a loser.

Rowing

Schedule Change: In the event of a race starting but not being completed (e.g. there is no deemed winner) then all bets will be void.

Rugby Union & League

Schedule Change: If a match is interrupted and continued within 48 hours after initial kick-off, all open bets will be settled with the final result. Otherwise all undecided bets are considered void.

Snooker

Schedule Change: In the event of a match starting but not being completed the player progressing to the next round or being awarded the victory will be deemed the winner for settlement purposes. Where revised match betting is offered (between sessions), one frame of the following session must be completed for bets to stand.

In all other bets if the statutory number of frames in a match are not completed, changed, or different from those offered for betting purposes then all bets will be void unless the outcome has already been determined. For example: if a match was abandoned after frame one with the score 1-0 to Player A then bets on Player A to win frame 1 would be settled as winners, and bets on Player B (the opponent) settled as losers. However, in the event of a disqualification or retirement bets will be declared void.

Table Tennis

Schedule Change: If a game is abandoned before regular time is played, all bets on that game are void, except for those bets (e.g. race to 10 points or winner of a specific game) where the result has already been determined.

If a postponed/rescheduled game takes place within 48 hours of the original start time, your bet on the game will stand, unless cancelled by mutual consent. However, if a game in the Olympics or World Championships is postponed bets will stand providing the game is rescheduled to take place before the closing ceremony.

If the game is no longer playing at the venue advertised, bets will still stand. This applies as long as the venue has not been changed to the opponent's ground (or as long as the venue remains in the same country for international games).

Bets on game will be void in the event of a game not taking place, or if a player/team is given a walkover.

Tennis

- o If there is a walkover, retirement, disqualification, or abandonment at any time after the start of the match, the player progressing to the next round will be deemed the winner. If a match is abandoned before the match has begun, all bets are "no action".
- o A tennis match is deemed to have started with the first serve of the match.
- All future book wagers on Tennis are "Action" once-event begins unless stipulated otherwise on kiosks or sports book sheets.
- If a match is suspended/postponed after the match has started, all full game wagers are "action" if completed within 48 Hours.
- For partial-match wagering (e.g., game and set betting), wagers are considered action upon the completion of the specified period; for example, 1st set wagers are action upon the completion of the 1st set.
- All tennis matches are "action" regardless of a venue change, surface change, court type, or change of scheduling as long as they are fully completed.

Schedule Change: All bets will be void in the event of a match starting but not being completed, except for bets where the outcome has already been determined. For example - a game is abandoned at 6-4, 5-1. In this instance, bets on the first set winner will be settled as a winner. The only exception to this rule is where a player is disqualified, after which the player or team progressing to the next round will be deemed the winner.

In the event that a tournament - or parts of a tournament - take place on a court surface or venue different than the one originally scheduled; the following rules will apply:

- Bets related to individual matches: if at least one ball is played on the court surface scheduled, all bets stand, according to the rules. If the complete match is played on another court surface than the one scheduled, all bets will be void.
- Tournament bets: if at least one ball is played on the court surface scheduled, all bets stand. If the complete tournament is played on another court surface, all bets are void.
- When assessing 'change of surface' there are three types of surface for our settlement purposes: Hard, Clay or Grass. If an event is moved from Outdoors to Indoors bets would still stand if the surface were to remain the same (i.e. changing from an outside hard court to an indoor hard court). Changing from outside grass court to indoor hard court would be classed as void in the circumstances listed above.
- Carpet is classed as a type of hard court for such settlement issues

Volleyball

Schedule Change: When a game venue is changed bets already placed will stand, but only when the home team is still designated as such and the game is not instead played at the away team venue, otherwise bets will be void.

Postponed or cancelled games will be treated as a non-runner for settling purposes, unless played within 48 hours of the original start time.

Winter Sports

Schedule Change: The following rules apply to the winter sports listed below:

- Alpine Skiing
- Biathlon
- Bobsleigh
- Cross Country Skiing
- Figure Skating
- Freestyle Skiing
- Luge
- Nordic Combined

- Short Track Speed Skating
- Skeleton
- Ski Jumping
- Snowboard
- Speed Skating

If a specific event (determined as: after a final competitor list is known) is suspended or postponed bets remain valid provided that the event is completed on the same run/same venue within 36 hours (with exception of Winter Olympic events). If the event takes place on a different run/venue bets will be made void and bet amounts returned.

Lost or damaged tickets

In the event a customer loses a winning ticket, or a ticket is presented which has been defaced or damaged to the extent that the barcode is unreadable. Mount Airy Sportsbook entirely at its discretion, undertakes to investigate and settle any returns due on the bet to the extent that the original ticket has not already been redeemed. The customer may be required to provide additional information and complete a Lost/Damaged Ticket form before any payment will be made. Any payment will be made within 30 days.

Lapsed Tickets

Any winning ticket shall be deemed lapsed and ineligible for payment one year after the date of the last sports event that forms the basis of such wager.
